A NEW MOVEMENT IS TAKING SHAPE IN AMERICA

The reproductive justice movement is led by women of color, young women, poor women, lesbian, bi- and transgender people, immigrant women, incarcerated women—people who at one time were consigned to the margins of American society. Together with their allies they have built organizations and won victories conventional wisdom said were not possible. Women of color-led organizations founded this movement and continue to be at its leading edge, doing significant work at the intersection of reproductive issues and LGBT rights, immigrant rights, environmental justice, ending violence against women, HIV prevention, and more.

THE CATALYST FUND AT TIDES

Tides is the proud home of The Catalyst Fund, the only national fund dedicated to supporting women of color-led efforts to advance reproductive justice. The Catalyst Fund provides matching grants to women's funds and community foundations across the nation that, in turn, support local women of color-led organizations. Taken as a whole, these groups are building a formidable and unified movement for reproductive justice—a movement with the power to win gains for all women.

WOMEN OF COLOR LEAD THE WAY

More than 35 years since *Roe vs. Wade*, American women continue to face a wide range of reproductive challenges. These challenges are intensified in communities of color, where economic inequalities, health disparities, and racial differences all play a role in compounding the pressures facing women and their families. Women of color in the U.S. experience disproportionately high rates of reproductive health problems and challenges to their reproductive rights. In response, women of color are working towards reproductive justice for all women. And in doing so, they have transformed these issues from hot buttons to powerful rallying points.

Sex Education - In New Mexico, where teen pregnancy rates are among the highest in the nation, a group of young women launched an effort against abstinence-only sex education in the public schools—even when traditional women’s groups said the fight was unwinnable. Young Women United pressured the state Board of Education to turn down federal abstinence-only funding and instead offer students medically accurate comprehensive sex education. Similar victories have been led by women of color in California, Chicago, and Washington, D.C.

Environmental Health & Justice - Organizing the owners and workers in nail salons, young Asian women joined a national campaign to take reproductive poisons out of nail products. They sought to pressure the largest manufacturers of those products by informing customers and salon workers about the health risks of exposure to dangerous chemicals. As a result, many leading cosmetic companies have reformulated their products using nontoxic ingredients.

Criminal Justice and Drug Policy Reform - Women in prison have been routinely shackled while giving birth. The Rebecca Project for Human Rights led a hard-hitting campaign to end this inhumane, intolerable practice, ultimately winning a ban on shackling in all federal prisons. Now they are working to extend the ban to all prisons and immigration detention facilities. They have also increased funding for family treatment as an alternative to incarceration for mothers who are battling substance abuse.

Protecting Access to Abortion - In California, three consecutive ballot measures threatened teen safety by denying them access to abortion without parental consent. The three-time defeat of these harmful initiatives would not have been possible without the work of women of color-led groups who brought together the labor movement, the ethnic media, and communities of color to bolster the fight for teen safety. Women of color-led groups have also helped defeat initiatives threatening abortion and contraception access in Georgia and Colorado.

“The Catalyst Fund represents two years of work by the Women of Color Working Group to address a critical funding gap. The persistent shortage of funding for an entire sector of women is weakening the ability of all women in the U.S. to secure their reproductive rights. Funders have the power and responsibility to reverse this trend, and with Catalyst, they now have a key opportunity.”

EXPANDING RESOURCES FOR REPRODUCTIVE JUSTICE

The Catalyst Fund at Tides was created to increase resources to women of color-led reproductive justice efforts. A collaborative fund that brings together like-minded funders to amplify their impact on the movement for reproductive justice, the Catalyst Fund provides matching grants and capacity building to local grantmaking partners throughout the U.S. To date it has moved \$1.4 million to women of color-led organizations with an additional \$2.5 million anticipated to reach the field in 2009 alone. Many of the national funders and grantmaking partners participating in the Catalyst Fund have doubled or tripled their giving to women of color-led reproductive justice efforts.

WHAT IS REPRODUCTIVE JUSTICE?

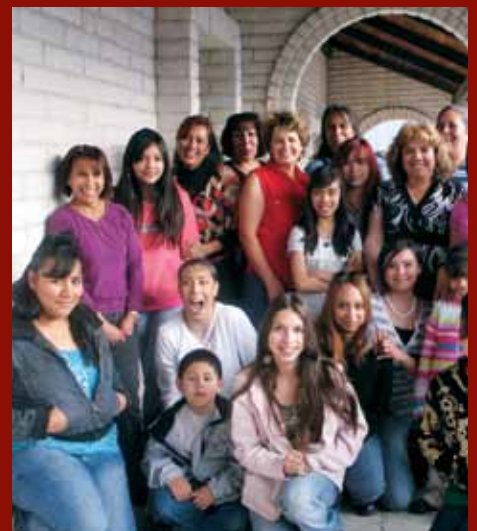
The reproductive justice movement is a new and transformational approach to advancing reproductive freedom in the U.S. It includes the full spectrum of reproductive issues that impact women’s lives—from the right to bear and raise healthy children to the right to terminate a pregnancy, access quality reproductive health care, and live in an environment that is free of toxins that harm reproductive health.

DIVERSE LEADERSHIP

The movement has a racially and generationally diverse leadership and base of support that reflect the nation’s changing demographics. It is fueled by a strategy for change in which the women directly affected by reproductive injustices lead grassroots organizing and advocacy efforts to transform the systems that impact their lives. Its strong links to other social justice issues inspire movements like those for labor and the environment to stand up for women in an unprecedented way.

A NATIONAL FRAME

Reproductive justice is now framing national conversations about reproductive rights and health. Partnering with reproductive justice leaders from around the nation, the premier progressive think tank, the Center for American Progress published the groundbreaking report, *More Than Choice: A Progressive Vision for Reproductive Health and Rights*. It propelled the reproductive justice movement into the national arena, and today the reproductive justice framework is reflected in President Obama’s platform on reproductive health.

THE RIPPLE EFFECT

REACHING DIVERSE GROUPS ACROSS THE COUNTRY

For national foundations, local funders, and individual donors, the Catalyst Fund offers an opportunity to create a ripple effect not just in dollars, but also in capacity building, increased visibility of women’s issues and reproductive justice, and commitment from others to the issues.

To date, the communication efforts of Catalyst grantmaking partners have reached 20,000 individual donors and dozens of local foundations. This education has resulted in hundreds of donors and many local foundations supporting reproductive issues for the first time. Forty percent of the individual donors who have contributed to the matching grant program are people of color, many of whom report that Catalyst has enabled them to see their local foundation as a home for their philanthropy for the first time. Grantmaking partners report a dramatic increase not only in the number and size of grants they are now making to this sector, but in the dedication of their boards and institutions to reproductive justice.

FUNDAMENTAL HUMAN RIGHTS

The movement for reproductive justice grew from the international human rights agenda which includes the rights to life, health, bodily integrity, non-discrimination, consent to and equality in marriage, and freedom from all forms of torture and other cruel, inhuman, and degrading treatment. In 1993, at the United Nations World Conference on Human Rights, the global community formally recognized that “women’s rights are human rights,” and created an action plan ratified by 185 nations (excluding the United States).



HOW THE CATALYST FUND'S MATCHING GRANT PROGRAM WORKS

Through the Catalyst Fund, philanthropists large and small pool their resources to support women of color-led reproductive justice organizations and projects. At the center of the fund is a matching grants program that receives contributions from national funders and re-allocates them, in the form of matching grants, to local women's funds and community foundations with a demonstrated commitment to women of color and reproductive justice. These grantmaking partners then fundraise with individual donors and other local foundations to meet the match and make grants to women of color-led organizations.

This approach offers strategic alignment among funders and donors who share a common interest. It provides an opportunity for them to bolster the power of their support—doubling the resources that ultimately reach women of color-led organizations and increasing contributions from new donors to the reproductive justice movement.
